## Message from the HOA President

On behalf of the Swan Lake HOA Board, I want to take a few minutes to remind everyone of the process for hosting events at the clubhouse. We hope that this explanation will clear up any misconceptions that some folks have.

## HOA APPROVED EVENT:

There is an HOA Events Calendar posted in the clubhouse. **Anything outside of that HOA calendar must be run past the Event Co-Ordinator**, Nel Rapini at Lot I-14. Her phone number is 609-457-8075.

Nel will explain the process, and determine if your event meets the HOA guidelines. Once approved, a plan would be set up by the host and Nel. You will be required to complete an Event Report, detailing your budget, a plan, etc. In this case, Swan Lake people attending your event would be also covered under the HOA insurance policy, as it is an added benefit to membership in the HOA. You must be a member of the HOA to be eligible.

(an example of this would be an HOA member wanting to host a breakfast, or an ice cream social for the residents)

## NON-HOA APPROVED EVENT:

If you wish to host a PRIVATE EVENT, or a NON-SPONSORED HOA event, **you will need to contact the office, and speak with the Swan Lake Office Manager**, Mary Ann Wandling at 941-756-8702. You will be required to provide proof of insurance coverage for your event, and the office will advise you of any fees for the use of the hall.

(an example of this would be a 'celebration of life' or 'private birthday party' with residents and/or non residents. ANY resident is eligible to host an event through the office, if approved by Management)

## Board Of Director 2024 Nominations

## AMENDED & RESTATED BY-LAWS OF SWAN LAKE VILLAGE HOME OWNERS ASSOCIATION, INC.

### ARTICLE VIII NOMINATIONS FROM THE FLOOR AND BY COMMITTEE AND ELECTION OF DIRECTORS

Section 1: NOMINATION Nomination for election to the Board of Directors shall be made by a Nominating Committee, whose report of it's nominees shall be made to the Board at the Membership Meeting held at least thirty (30) days prior to the Annual Membership (Association) Meeting. Members of the Nominating Committee shall not be a member of the Board of Directors and two or more members of the Association, who are not members of the Board. The Nominating Committee shall make as many nominations for election to the Board of Directors as it shall in its discretion determine, but not less than the number of vacancies that are to be filled, which will be three (3) nominees in odd years and four (4) nominees in even years.

All nominations from the floor must be made at a duly noticed membership meeting held at least thirty (30) days before the Annual Membership Meeting, and at the conclusion of said meeting, nominations for election to the Board of Directors shall be closed.

No nominations from the floor shall be accepted at the annual meeting nor shall a nominee be eligible unless her/she has been a member in good standing for more than one year.

The Origins and Meaning of Boxing Day Boxing Day, celebrated on December 26, is a holiday rich in tradition, historical significance, and cultural variations across countries, primarily in the United Kingdom, Canada, Australia, and New Zealand. Despite its name, Boxing Day has no association with the sport of boxing but rather originates from a blend of social, religious, and historical influences dating back to the 19th century. This day follows Christmas and has come to represent a time of giving, relaxation, and celebration.

The roots of Boxing Day trace back to Victorian England, during the reign of Queen Victoria. Although its exact origins remain somewhat ambiguous, one popular theory links it to the practice of wealthy families and aristocrats providing gifts and bonuses to their household staff and servants. Christmas Day was traditionally a working day for many servants, as they helped prepare feasts and celebrations for the families they served. In recognition of their hard work, these families would “box up” gifts, leftovers, or money, presenting these tokens of appreciation to their staff on the day after Christmas. Thus, the name “Boxing Day” is thought to derive from these “Christmas boxes” or gift boxes given to employees as a gesture of goodwill and gratitude.

Another theory points to the church’s practice of setting up collection boxes for alms, which were filled with donations from parishioners. On December 26, the Feast of St. Stephen, these boxes would be opened, and the contents distributed to the poor. St. Stephen, known as the first Christian martyr and a symbol of charitable giving, was a natural fit for this day of community support and compassion. The association with almsgiving and the charitable distribution of gifts on Boxing

Day emphasizes a theme of kindness, which remains central to the holiday’s purpose.

Over time, the observance of Boxing Day evolved, taking on new meanings and traditions in different countries. In the United Kingdom and other Commonwealth nations, it has become a public holiday—a day for rest, leisure, and family gatherings. In many areas, Boxing Day also became a day for sports, especially horse racing, football, and rugby, with events and tournaments held specifically to commemorate the day. Additionally, in more recent years, Boxing Day has taken on a commercial angle, similar to Black Friday in the United States. Retailers offer major sales, and stores open early to draw in shoppers looking for post-Christmas bargains.

Despite the modern emphasis on shopping and leisure, the original spirit of Boxing Day remains influential. Many people still use the holiday as an opportunity to engage in charitable acts, such as donating to those in need or volunteering at local organizations. This emphasis on generosity serves as a reminder of Boxing Day’s historical origins, linking back to the themes of compassion and community support that shaped the day centuries ago.

In essence, Boxing Day has transformed over the years from a Victorian custom of gifting and gratitude into a multi-faceted holiday. Whether spent shopping, enjoying family activities, or giving to charity, the day continues to be a meaningful extension of the Christmas season, encouraging both celebration and compassion. Its evolution reflects the adaptability of traditions, allowing Boxing Day to remain a cherished holiday in many cultures today.

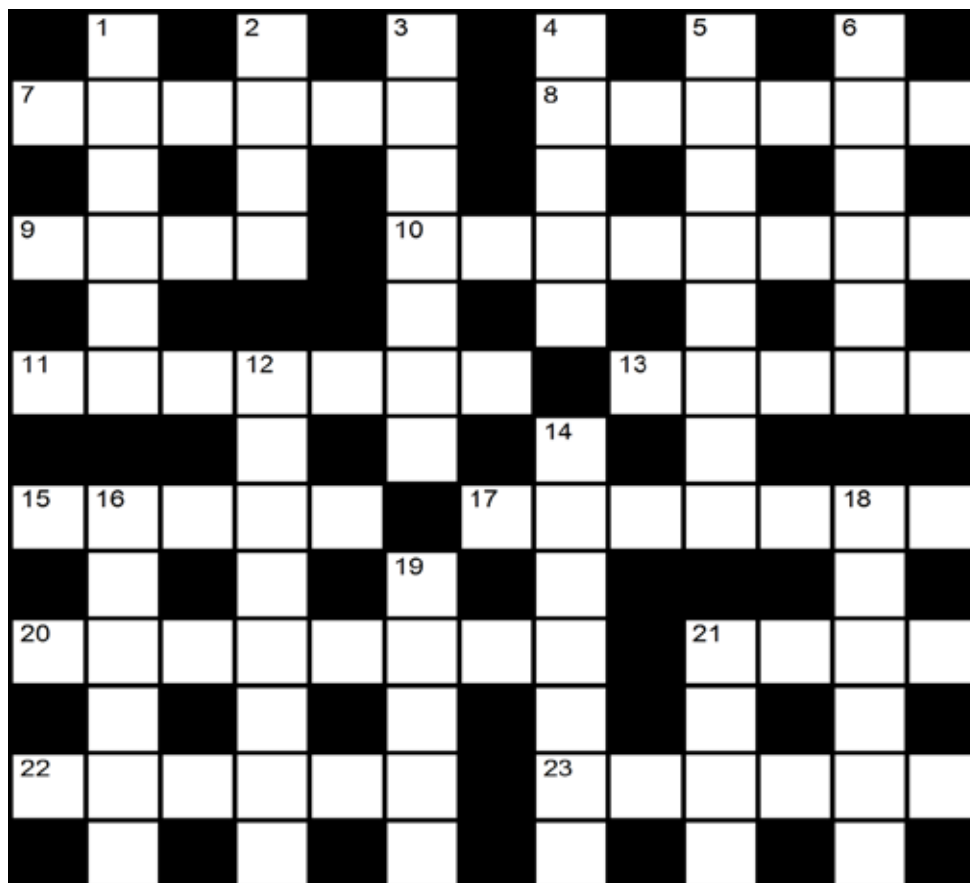

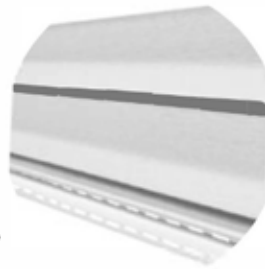

## WORDS OF WISDOM FROM SHERIFF CHRIS



### PHONE SCAM 📞 🚨:

We continue to receive reports of scammers claiming to be Manatee County Sheriff's Office deputies and requesting payment for various reasons.

The most recently reported scam involves someone pretending to be an MCSO

Civil Unit deputy (who identifies as Officer Kenny West). In multiple instances, the scammer states the person has outstanding traffic tickets and needs to pay them off to avoid having a warrant for their arrest.

Some victims believed the scammer because the scammer cited REAL traffic citations they had received and paid off in the past. Please be aware that much of this information is publicly accessible online through records on your county's Clerk of the Court website, and scammers use this info to mislead people into trusting that their request is legitimate.

Here are a few RED FLAGS to watch out for on scam calls like this:

- ▶ Scammer impersonates a government official or law enforcement officer, often "Caller ID Spoofing" the phone numbers for real agencies.
- ▶ Scammer instills a sense of urgency and threat of impending consequences
- ▶ Scammer uses information that is publicly available to gain trust
- ▶ Scammer requests payment through gift cards, cash transfer apps, or a mail courier service

Remember - we will never ask for money to avoid an arrest warrant! If you experience a call like this from someone claiming to be a deputy or staff member of the Manatee County Sheriff's Office, do not provide payment. Hang up and call us on our non-emergency phone line to report the call: (941) 747-3011.

To return borrowed articles simply place them into the Returns Basket on the table in the library area.

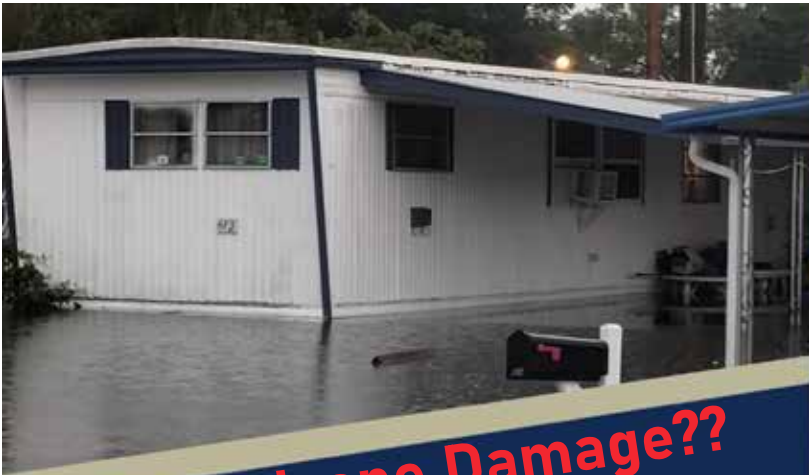

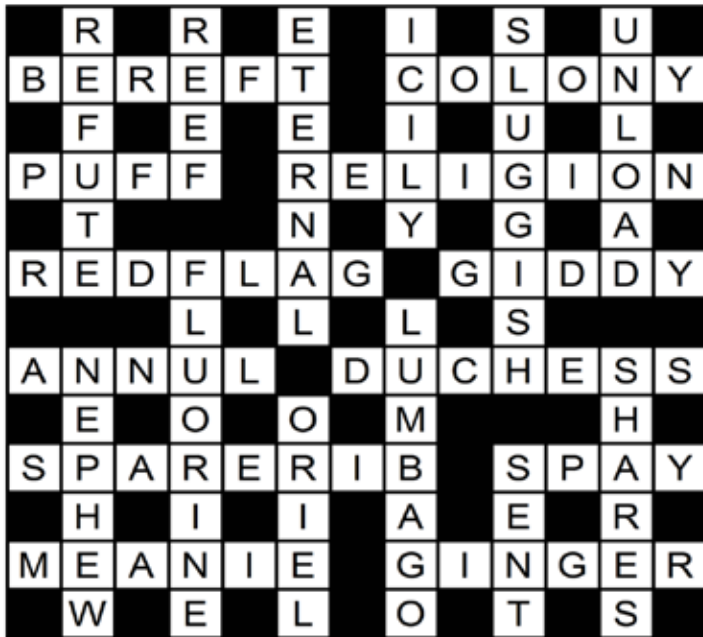
